

PART 5 - DECLARATION AND CONSENT TO THE RELEASE OF INFORMATION

By signing this application:

- I consent to a police records and background check. This consent includes the release of records of criminal convictions for which a pardon has not been granted, any information held by local police services, records of discharges which have not been removed from the national record repository maintained by the RCMP in accordance with the *Criminal Records Act*, or any convictions registered, charges pending or any other judicial order issued under an Act of Parliament or an Act of the Legislature.
- I further acknowledge that such a check would include, but not be limited to a record of outstanding warrants, charges and unpaid provincial fines.
- I consent to the disclosure of the results of a police records and background check to the Registrar or to any person authorized by him or her.
- I consent to an investigation of my immigration status in Canada by the immigration authorities and to disclose the results of an investigation to the Registrar.
- I authorize the police records and background check to be performed by any police service that is requested by the Registrar to perform the check, and I authorize the Registrar to disclose any information collected about me, to any police service for the purposes of performing a police records and background check.

This consent is given pursuant to subsection 39(1) paragraph (a) and subsection 42(1) paragraph (b) of the *Freedom of Information and Protection of Privacy Act* and subsection 29(1) paragraph (a) and subsection 32(b) of the *Municipal Freedom of Information and Protection of Privacy Act*.

In addition, the licence may be refused.

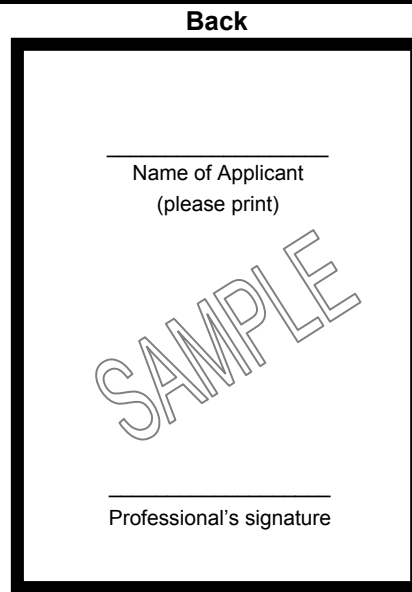
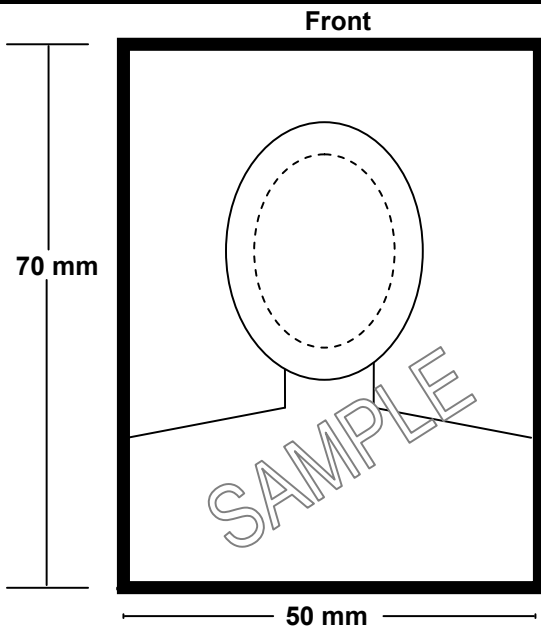

- Submit one passport quality photograph
- Approximately 50mm x 70mm (passport photo size)
- Show a full front view of face and shoulders squared to the camera
- Clear, sharp and in focus
- Show both edges of the face clearly
- No sunglasses

- No shadows or flash reflection on the face / head
- Taken with uniform lighting
- Taken against a plain, uniform, white or light-coloured background
- No retouched photos, photos that peel or group photos
- Eyes must be open and clearly visible
- Can be a black and white or colour photo
- No hats or head coverings unless for religious reasons and only if the full facial features are clearly visible
